- 27. For the purpose of these terms, a Day is defined as a trading day that is determined by the trading hours of each Participating Venue.

### Recordkeeping

- 28. Player Elite and the Promoter will keep a log of virtual entries for 3-months after the draw date.
- 29. A prize register will be maintained & kept by The Promoter for at least 12-months after the end of the Promotion Period.

- 33.
